

EVACUATION ORDER RESCINDED SLRD ELECTORAL AREA A Bonanza Creek K71082 Wildfire

August 31, 2026, at 1700 hrs

Based on consultation with the BC Wildfire Service, the SLRD has assessed the potential danger to life and health due to the Bonanza Creek Wildfire has subsided to the degree that the **Evacuation Order** issued pursuant to Section 95(1) of the BC *Emergency and Disaster Management Act*, by the Squamish-Lillooet Regional District on July 22, 2026, at 2000 hrs and updated on August 28, 2026, at 1700 hrs, is no longer required.

An Evacuation Alert or Order may need to be reissued for the properties in the Rescind Area. If that is deemed necessary, the Evacuation Alert process will be recommenced.

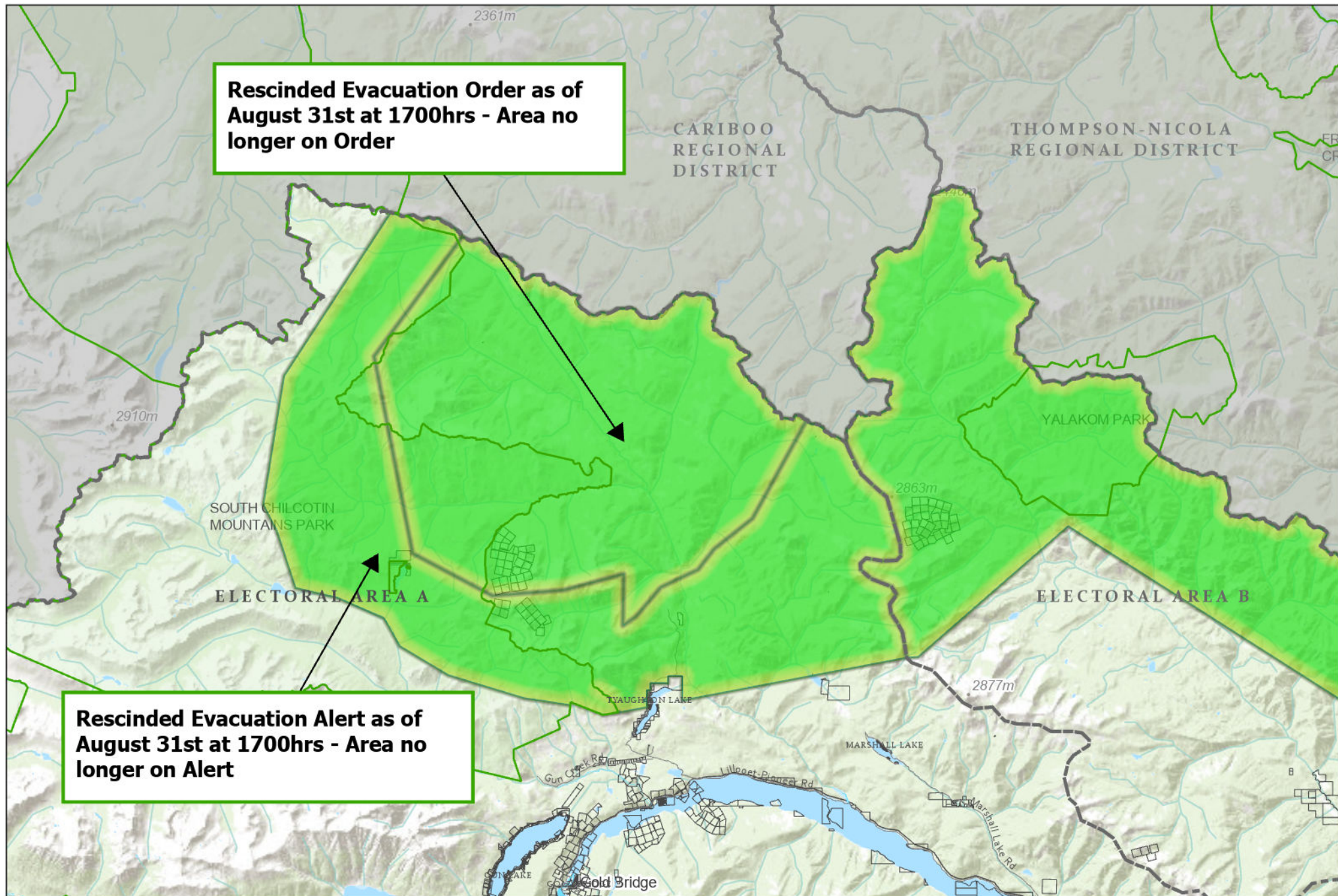
