

EVACUATION ALERT – SLRD ELECTORAL AREA B RILEY CREEK WILDFIRE K70659

Updated: August 2, 2026, at 19:00 hrs

Based on recommendations from the BC Wildfire Service, the **Evacuation Order** that was issued by the Squamish-Lillooet Regional District on July 31, 2026, at 1900hrs, for the Texas Creek vicinity due to the Riley Creek Wildfire (K70659) has been downgraded and replaced by an **Evacuation Alert**. This Alert combines the existing Evacuation Alerts issued on July 21 and July 31, 2026. All affected properties listed below remain under Evacuation Alert:

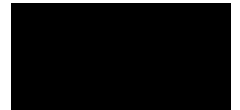

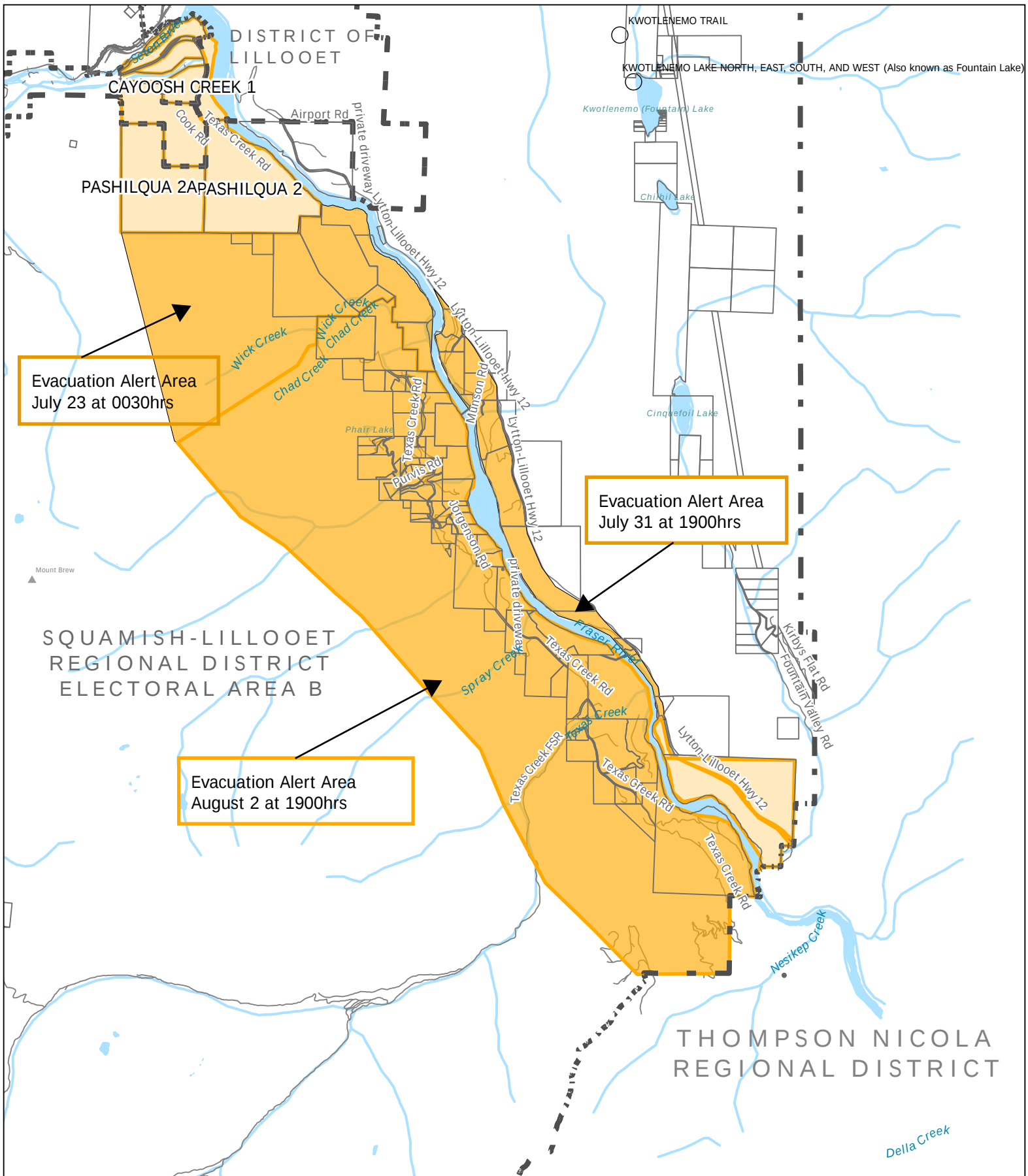
WHAT YOU SHOULD DO:

- Preregister for Emergency Support Services online at: <https://ess.gov.bc.ca/>
- For questions call 1-844-815-6199 to access the SLRD's 24/7 Public Information Line.
- Locate all family members and designate a meeting area outside of the evacuation area, should an Evacuation Order be called while separated.
- Pack essential items such as government-issued ID, medications, eyeglasses, valuable papers (e.g., insurance, credit, and mortgage information), immediate care needs for dependents and, if time and space permits, keepsakes for quick departure.
- Prepare to move people who may need additional time to evacuate, children and/or neighbours who would require assistance.
- Prepare to take pets with you and move livestock to a safe area (if possible).
- Impacted agricultural producers can contact the SLRD Agricultural Coordinator directly at 604-384-7329.
- Arrange transportation and accommodations for all your household members, if possible, and fill the gas tanks of personal vehicles.
- Wait for an Evacuation Order to be issued before evacuating.
