

EVACUATION ALERT RESCINDED – SLRD AREA B PEAR LAKE WILDFIRE C40983

September 8, 2026, at 1300

Based on consultation with the BC Wildfire Service, the SLRD has assessed that potential danger to life and health due to the Pear Lake Wildfire C40983 has subsided to the degree that the current Evacuation Alert issued pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, is no longer required.

Effective September 8, 2026, at 1300, the Squamish-Lillooet Regional District has rescinded the Evacuation Alert for the following properties:

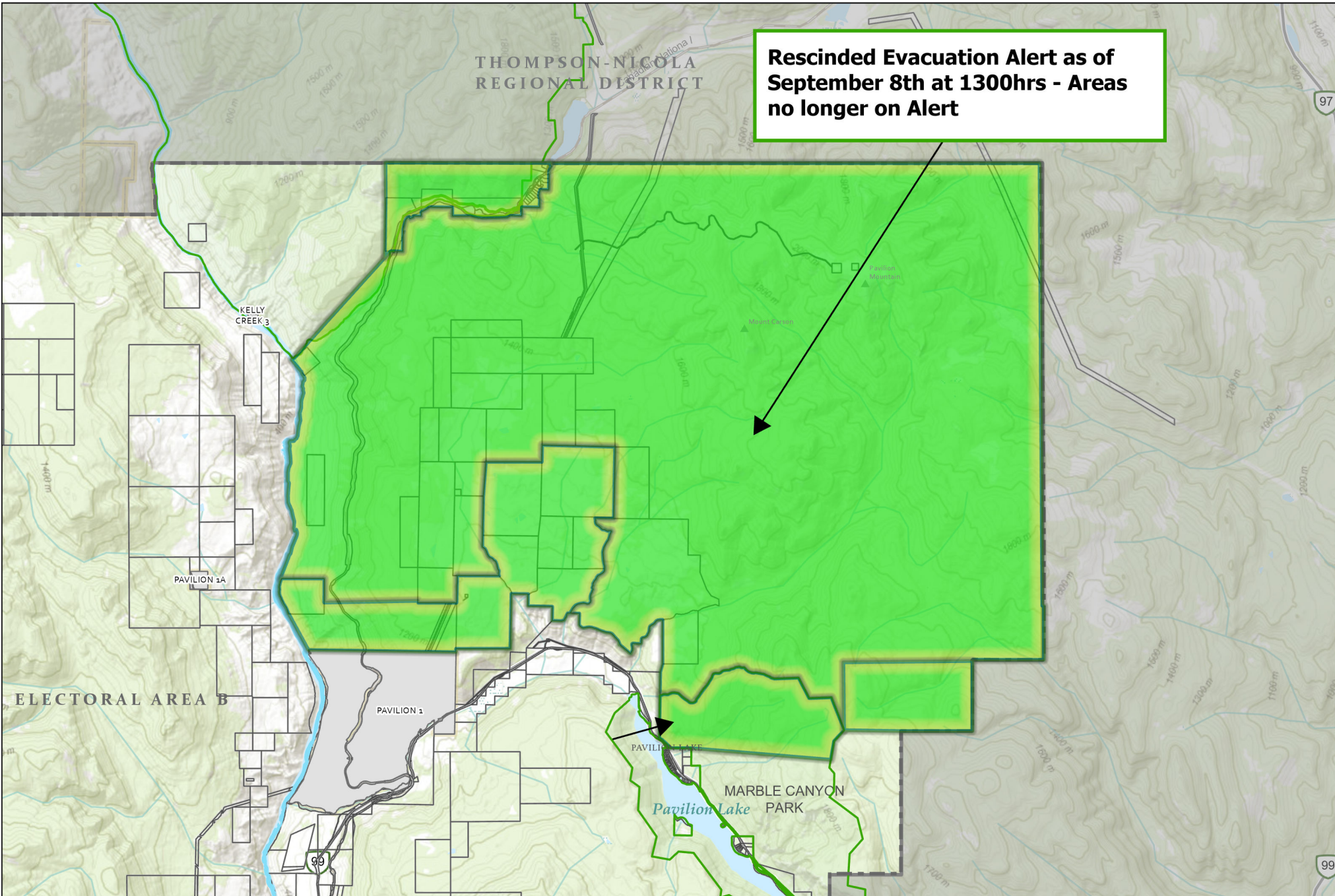
