

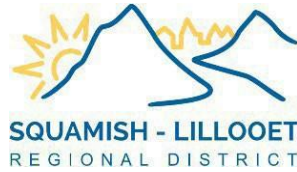
**EVACUATION ALERT RESCINDED
SLRD ELECTORAL AREA B
PEAR LAKE WILDFIRE C40983**

August 31, 2026 at 1700 hrs

Based on consultation with the British Columbia Wildfire Service, the SLRD has assessed that the potential danger to life and health due to the Bonanza Creek wildfire has subsided to the degree that the **Evacuation Alert**, issued pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, by the Squamish-Lillooet Regional District in Electoral Area A, is no longer required.

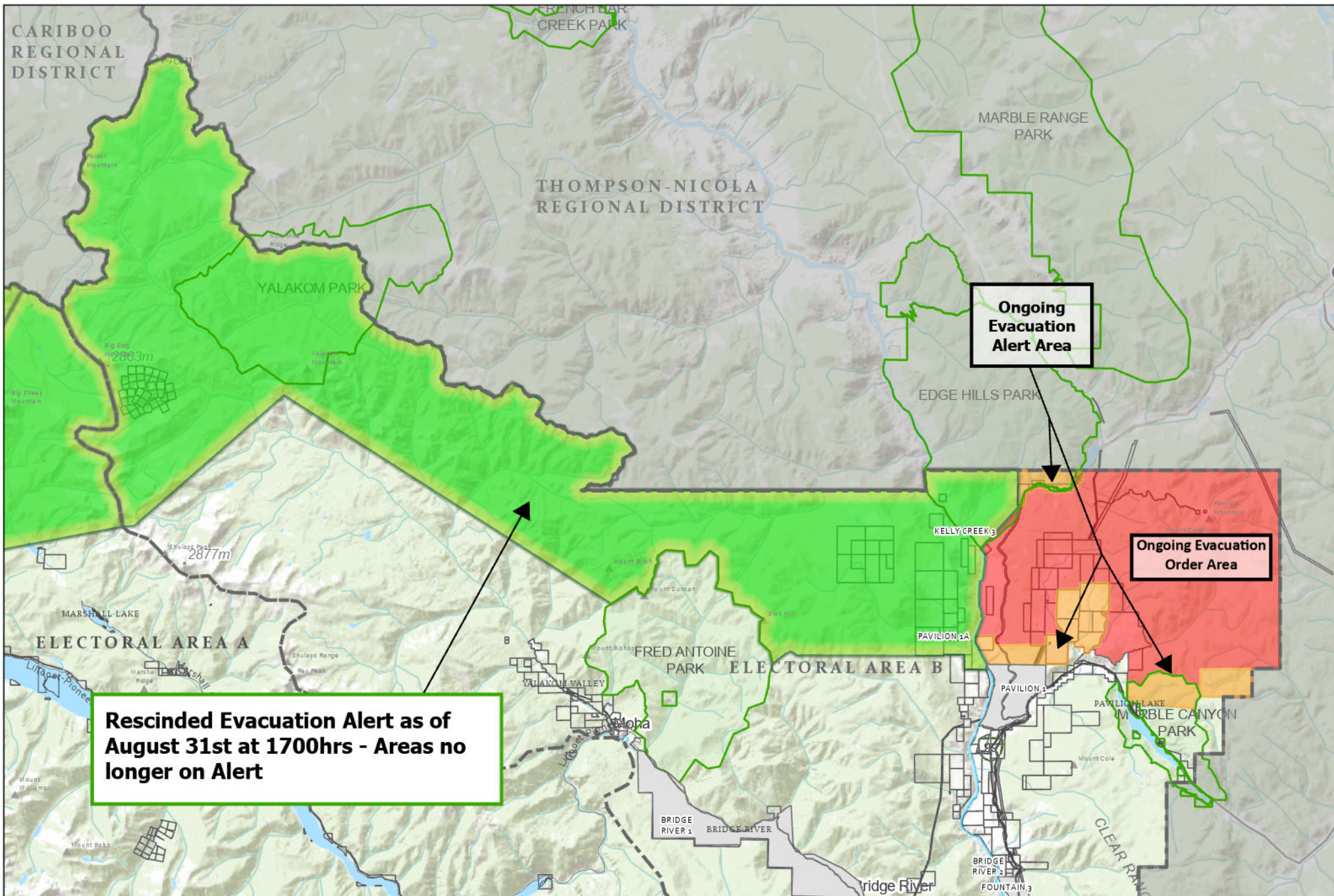
