

UPDATED EVACUATION ALERT – SLRD ELECTORAL AREA B RILEY CREEK WILDFIRE K70659

Updated: July 31, 2026, at 19:00 hrs

Based on recommendations from the BC Wildfire Service, the **Evacuation Alert** that was issued by the Squamish-Lillooet Regional District on July 23, 2026, at 0030hrs, and updated on July 30, 2026 at 1930 hrs, for the Texas Creek vicinity due to the Riley Creek Wildfire (K70659) has been updated further to include the below list of properties for the existing evacuation alert.

Because of the potential danger to life and health, the Squamish-Lillooet Regional District has issued an updated **Evacuation Alert** to include the following properties:

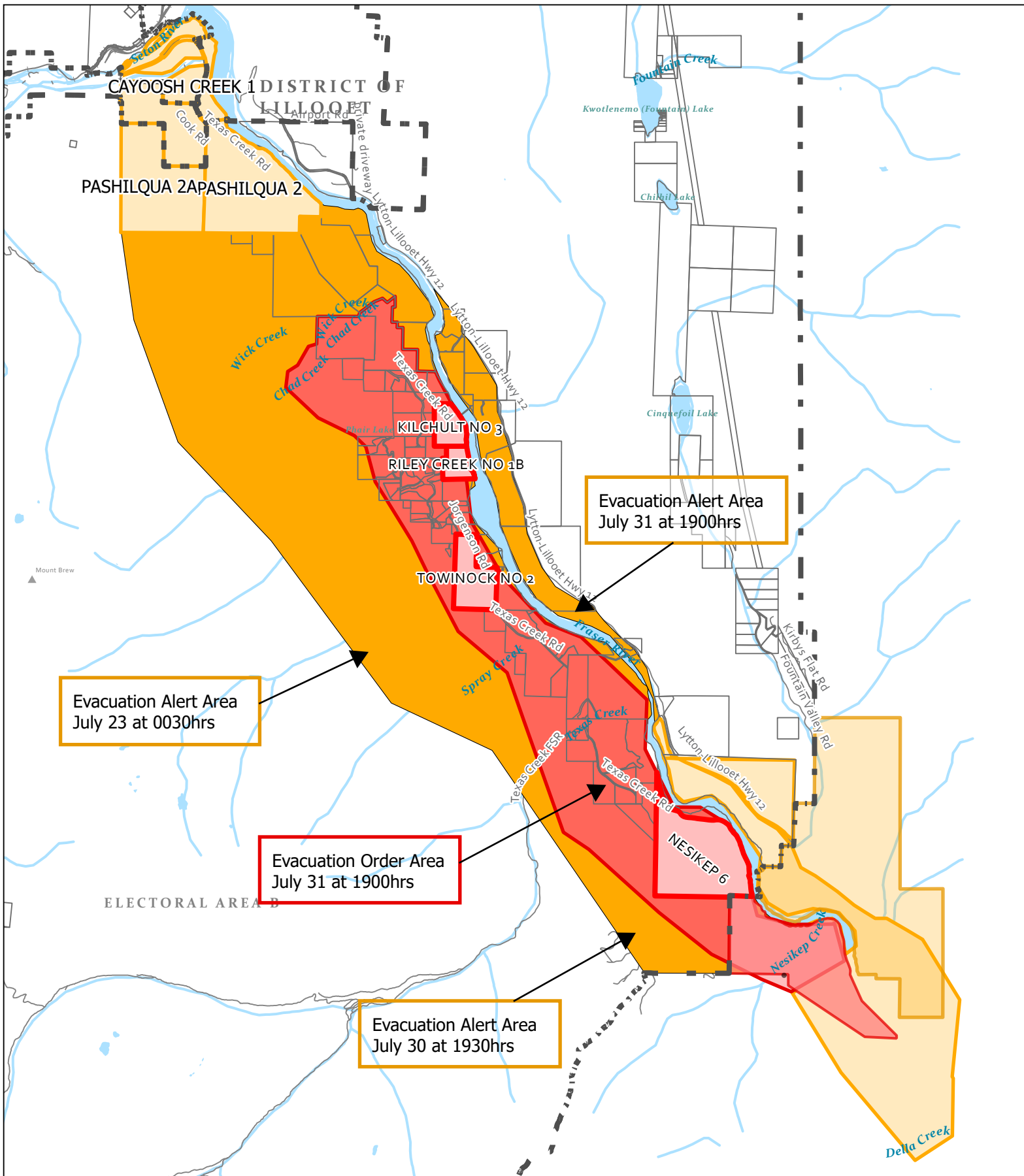
This updated **Evacuation Alert** has been issued to prepare you to evacuate your premises should it be found necessary. Residents will be given as much advance notice as possible before evacuation; however, you may receive limited notice due to rapidly changing conditions.

NOW IS THE TIME TO PREPARE FOR AN EVACUATION

WHAT YOU SHOULD DO:

- Preregister for Emergency Support Services online at: <https://ess.gov.bc.ca/>
- Call 1-844-815-6199 to access the SLRD's 24/7 Public Information Line for questions related to wildfire emergency measures.
- Locate all family members and designate a meeting area outside of the evacuation area, should an Evacuation Order be called while separated.
- Pack essential items such as government-issued ID, medications, eyeglasses, valuable papers (e.g., insurance, credit, and mortgage information), immediate care needs for dependents and, if time and space permits, keepsakes for quick departure.
- Prepare to move people who may need additional time to evacuate, children and/or neighbours who would require assistance.
- If you require assistance, call the SLRD Emergency Operations Centre (EOC) at 604-384-7357.
- Prepare to take pets with you and move livestock to a safe area (if possible).
- Arrange transportation and accommodations for all your household members, if possible, and fill the gas tanks of personal vehicles.
- Wait for an Evacuation Order to be issued before evacuating.
