

EVACUATION ALERT UPDATED – SLRD ELECTORAL AREA B RILEY CREEK WILDFIRE K70659

Issued: August 24, 2026, at 1230 hrs

Based on recommendations from the BC Wildfire Service, an **updated** EVACUATION ALERT has been issued by the Squamish-Lillooet Regional District for the Riley Creek Wildfire (K70659) burning out of control in the Texas Creek area, uphill of Texas Creek Road, in Electoral Area B.

The Riley Creek Wildfire Evacuation Order has been downgraded to an Evacuation Alert as of August 24 at 12:30hrs. This Evacuation Alert is being updated to include these properties.

Because of the potential danger to life and safety, the Squamish-Lillooet Regional District has issued an **updated** EVACUATION ALERT for the **following properties**:

An Evacuation Alert has been issued to prepare you to evacuate your premises should it be found necessary. Residents will be given as much advance notice as possible before evacuation; however, you may receive limited notice due to rapidly changing conditions.

NOW IS THE TIME TO PREPARE FOR AN EVACUATION

WHAT YOU SHOULD DO:

- Pre-register for Emergency Support Services online at: <https://ess.gov.bc.ca/> or call the Canadian Red Cross 24/7 Duty Officer line at **1-888-800-6493**
- Locate all family members and designate a meeting area outside of the evacuation area, should an Evacuation Order be expanded while separated.
- Pack essential items such as government-issued ID, medications, eyeglasses, valuable papers (e.g., insurance, credit, and mortgage information), immediate care needs for dependents and, if time and space permits, keepsakes for quick departure.
- Prepare to move people who may need additional time to evacuate, children and/or neighbours who would require assistance.

- Impacted or concerned agriculture producers are asked to please contact **SLRD Agricultural Coordinator directly at 604-384-7329**
- If you require assistance, call the **SLRD Emergency Operations Centre (EOC) at 604-384-7357**.
- Prepare to take pets with you and move livestock to a safe area (if possible).
- Arrange transportation and accommodations for all your household members, if possible, and fill the gas tanks of personal vehicles.
- Wait for an Evacuation Order to be issued before evacuating.
