

EVACUATION ORDER EXPANDED – SLRD ELECTORAL AREA B RILEY CREEK WILDFIRE K70659

Issued: August 9, 2026, at 1630 hrs

Pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, an EVACUATION ORDER issued by the Squamish-Lillooet Regional District due to immediate danger to public safety caused by the Riley Creek Wildfire has been **expanded** to include an additional property on Texas Creek Road in the Texas Creek area effective August 9, 2026 at 1630 hrs. Members of the Royal Canadian Mounted Police and other applicable agencies will be expediting this action.

The EVACUATION ORDER issued on August 7, 2026 for properties in the Texas Creek area remains in effect.

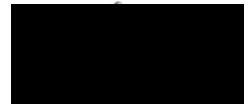

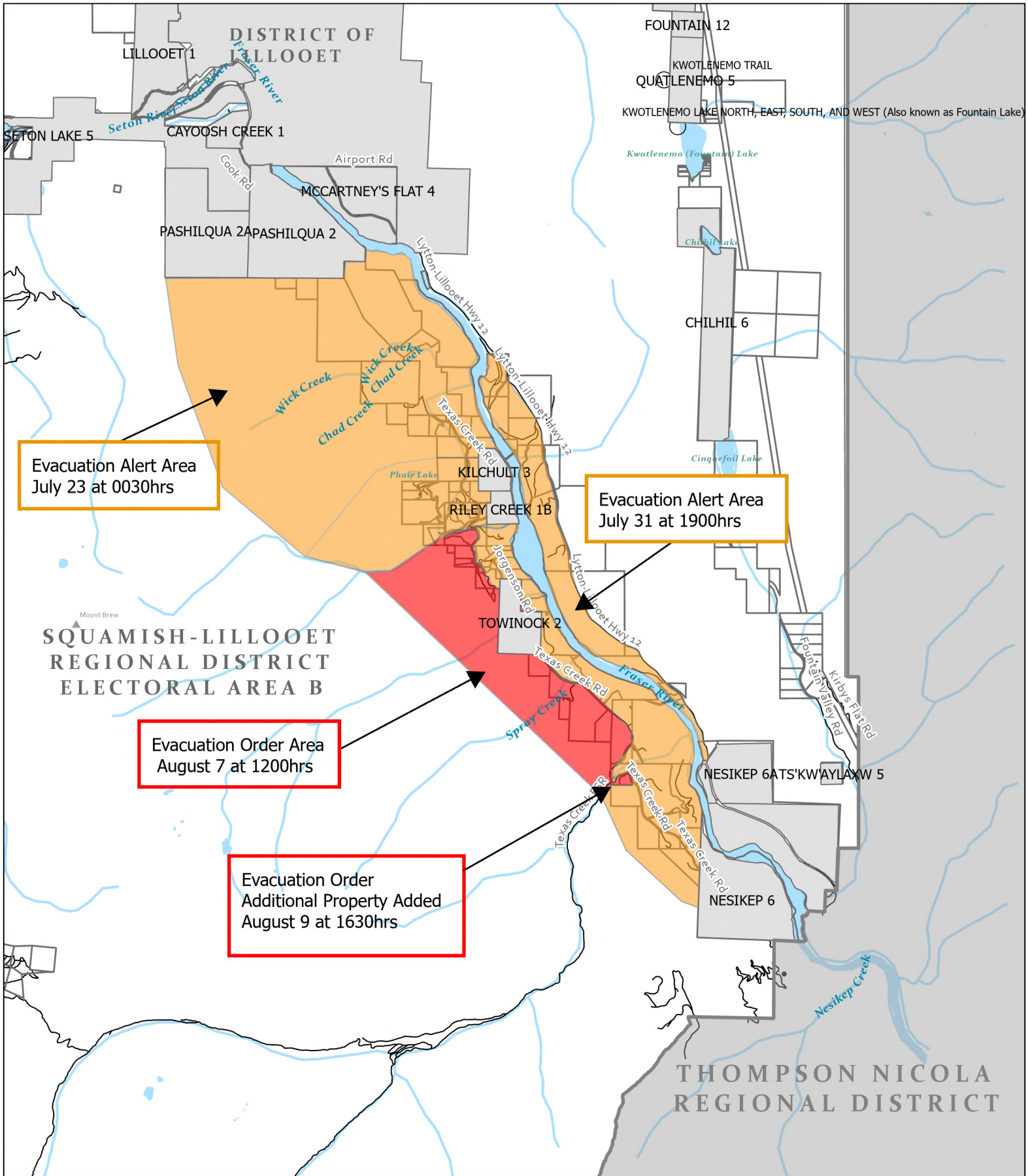
