

EVACUATION ORDER – SLRD AREA B PEAR LAKE WILDFIRE C40983

July 20, 2026, at 1630 hrs

Pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, an **Evacuation Order** has been issued by the Squamish-Lillooet Regional District due to immediate danger to life safety caused by the risk of wildfire in the Pear Lake area in Electoral Area B.

Members of the Royal Canadian Mounted Police and other applicable agencies will be expediting this action.

This Evacuation Order is in effect for the following SLRD properties in Electoral Area B:

- 340 Pear Lake Rd
- 280 Pear Lake Rd
- 220 Pear Lake Rd
- 400 Pear Lake Rd
- 650 Pavilion-Clinton Rd
- 975 Pavilion-Clinton Rd
- 865 Pavilion-Clinton Rd
- 560 Pavilion-Clinton Rd
- 805 Pavilion-Clinton Rd
- 980 Pavilion-Clinton Rd
- All SLRD properties as outlined in the attached map.

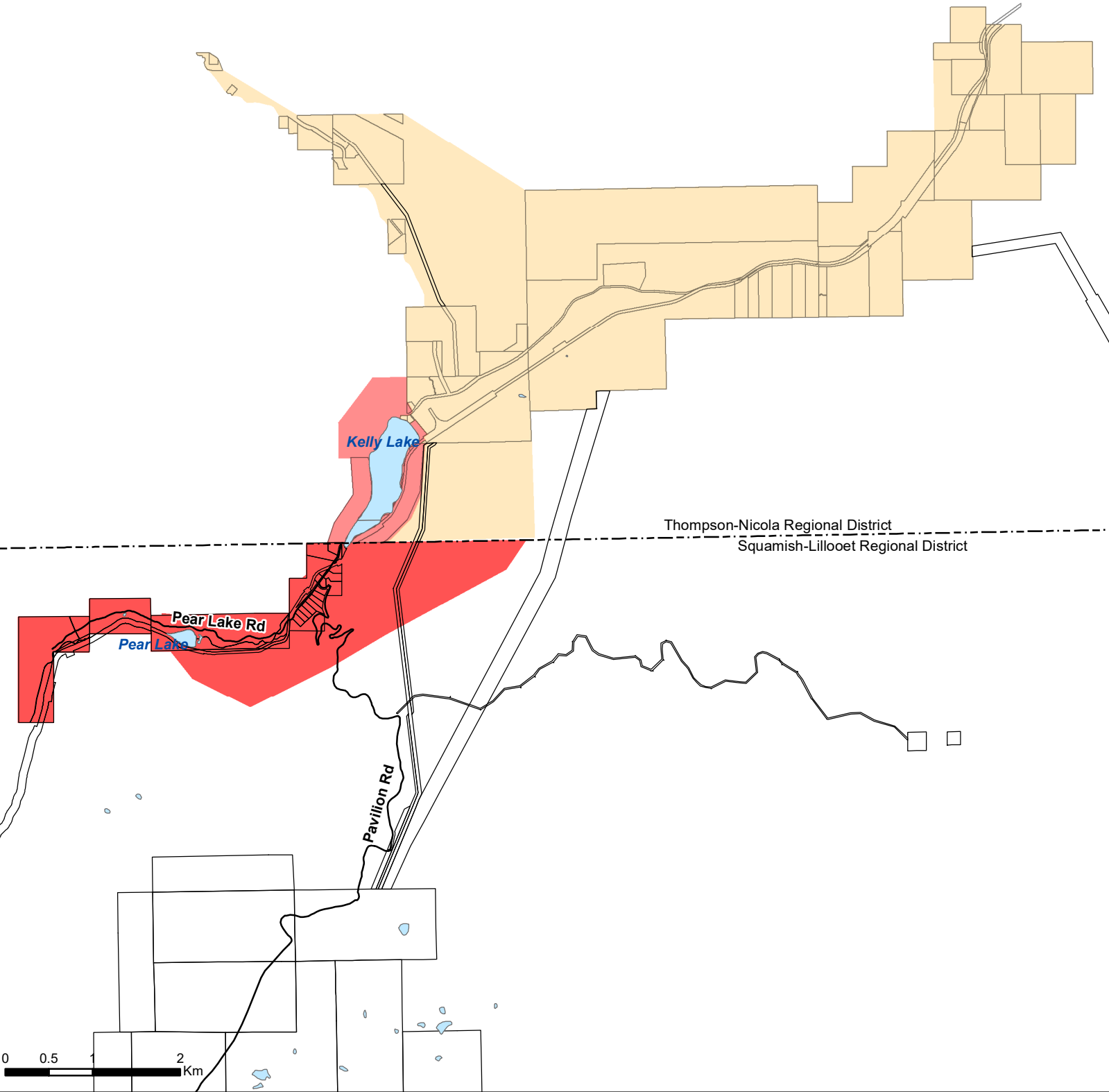
