The Evacuation Order, pursuant to Section 95 (1) of the BC *Emergency and Disaster Management Act* issued by the Squamish-Lillooet Regional District on July 23 and July 30, 2026 in Electoral Area C has been downgraded to an **Evacuation Alert** for the following properties:

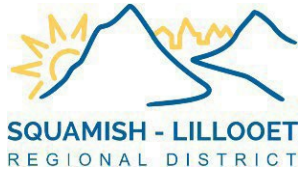

The existing Evacuation Alert area spanning Strawberry Point Recreation Site, Twin One Creek Recreation Site, Driftwood Bay Recreation Site, the Lizzie Bay Recreation Site, and extending north along the In-Shuck Ch FSR remain on Evacuation Alert, as per the attached map. These recreation sites remain closed.

WHAT YOU SHOULD DO:

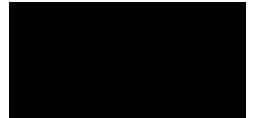
- Visit www.DriveBC.ca and confirm that your intended route home is not obstructed by road closures

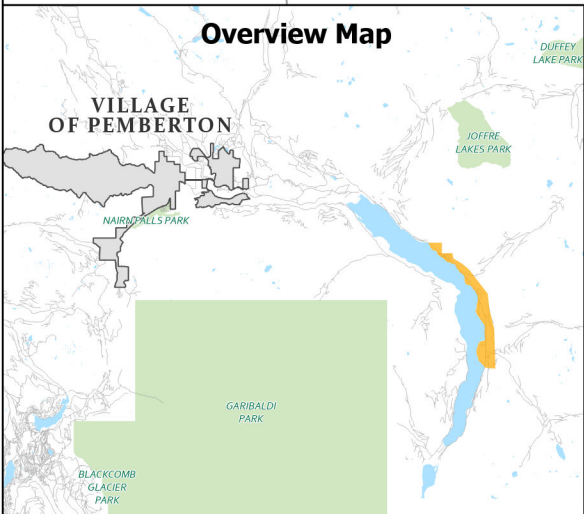
