

# NOTICE of FILMING

GEP Resident Inc. will be returning to Minaty Bay to film sequences for Season 4 of, "Resident Alien". Please take a moment to read this notice regarding our upcoming filming taking place on **January 8th & 9th, 2025** with preparation and restoration happening on **January 2nd, 3rd, 6th, 7th and January 10th, 2025**.

The following is a brief outline of our filming activity:

## PREPARATION

**January 2nd, 3rd, 6th, 7th 2025 7am - 7pm approx.**

- A smaller crew will be in the area making preparations for filming. All activities will be confined to private property. There are no loud noises associated with any of this work. Our film unit will arrive on-site on **Tuesday**, January 8th, 2025.

## FILMING

**January 8th & 9th, 2025 6am - 11pm approx.**

- The filming crew will arrive at Minaty Bay and begin work at various spots throughout the property. All filming activity will be confined to private property. There are no loud noises, pyrotechnics, special effects, or gunfire associated with this work. We do not anticipate any disruption to local residents at any point.

## RESTORATION

**January 10th, 2025 7am - 7pm approx.**

- A small crew will return to wrap the location. All activity will be confined to private property.

For the duration of our time in Minaty Bay, there will be no disruption to traffic in the area, as all activities are confined to private property. We do not anticipate the use of atmospheric smoke, loud noises, or aircraft. Some of the filming may involve the use of a small camera drone around the filming area.

The following Terms & Conditions are attached to this Operating Permit:

1. Technical Safety BC must be advised in writing of any change in owner or agent within 72 hours of the change coming into effect.
2. For Permit Class: **“Temporary Construction Service”** the Permit holder is authorized to install and operate the temporary service for a period not to exceed one year from original installation.
3. For Permit Class: **“Temporary Operating”**:
  - a. The named FSR will submit a Contractor Declaration Form for each installation set up as per the provided route list, and will contact the applicable Safety Officer to arrange for a site inspection **24 hours** prior to the installation being energized for use.
  - b. Permission is given to energize equipment for TESTING purposes only.
  - c. **The named FSR will provide his/her current contact information in conjunction with a current up to date location list for the term of this operating permit.**
  - d. **The location list will contain the following details for each location: date of show, city/town; civic address; name of site.**
  - e. The named FSR will be available for all necessary site inspections along with the Safety Officer for the area, as per the provided site list.
  - f. The named FSR will ensure all regulated work complies with the Safety Act of BC, the Safety Standards General Regulations, and the Electrical Safety Regulations, the current version of the Canadian Electrical Code, and any applicable directives and amendments current in BC.
  - g. The named FSR will comply with any and all directions stated on the issued Certificate of Inspection.
  - h. The named FSR will ensure persons doing electrical regulated work are qualified.
  - i. The named FSR will inform Technical Safety BC if he/she ceases to be the named FSR for the permit.

2. Electrical systems must be operated and maintained in accordance with the Safety Standards Act ("the Act") and Regulations.
3. Technical Safety BC is to be notified of any incident that results in an injury to any person or damage to the regulated equipment. To report an incident, go to [www.technicalsaftybc.ca](http://www.technicalsaftybc.ca) (search: "report an incident").
4. The holder of this permit must not allow regulated work to be undertaken by individuals under the permit unless they are authorized under the Safety Standards Act.
5. The holder of this permit must maintain a log of all work performed under this permit.
6. The holder of this permit must inform Technical Safety BC if the named field safety representative ceases to be contracted or employed by the permit holder.
7. The holder of this permit must renew the permit upon receipt of renewal notice.
8. Variances must be obtained prior to the applicable changes of the operation.

If you disagree with a term or condition applied to this permit, you may request, in writing, a Safety Manager review within 30 days from the date of issue.
