

EVACUATION ORDER EXPANDED – SLRD ELECTORAL AREA B PEAR LAKE WILDFIRE C40983

Issued: Aug 22, 2026, at 0800 hrs

Pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, an EVACUATION ORDER issued by the Squamish-Lillooet Regional District due to immediate danger to public safety caused by the Pear Lake Wildfire has been **expanded** to include additional areas in the Pavilion Lake and Marble Canyon area effective August 22, 2026 at 0800 hrs. Members of the Royal Canadian Mounted Police and other applicable agencies will be expediting this action.

The EVACUATION ORDERS issued on July 20, July 25, and August 6, 2026 for properties in the Pear Lake area and south of Pear Lake remain in effect.

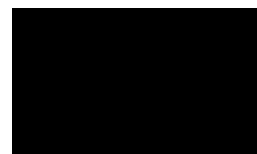

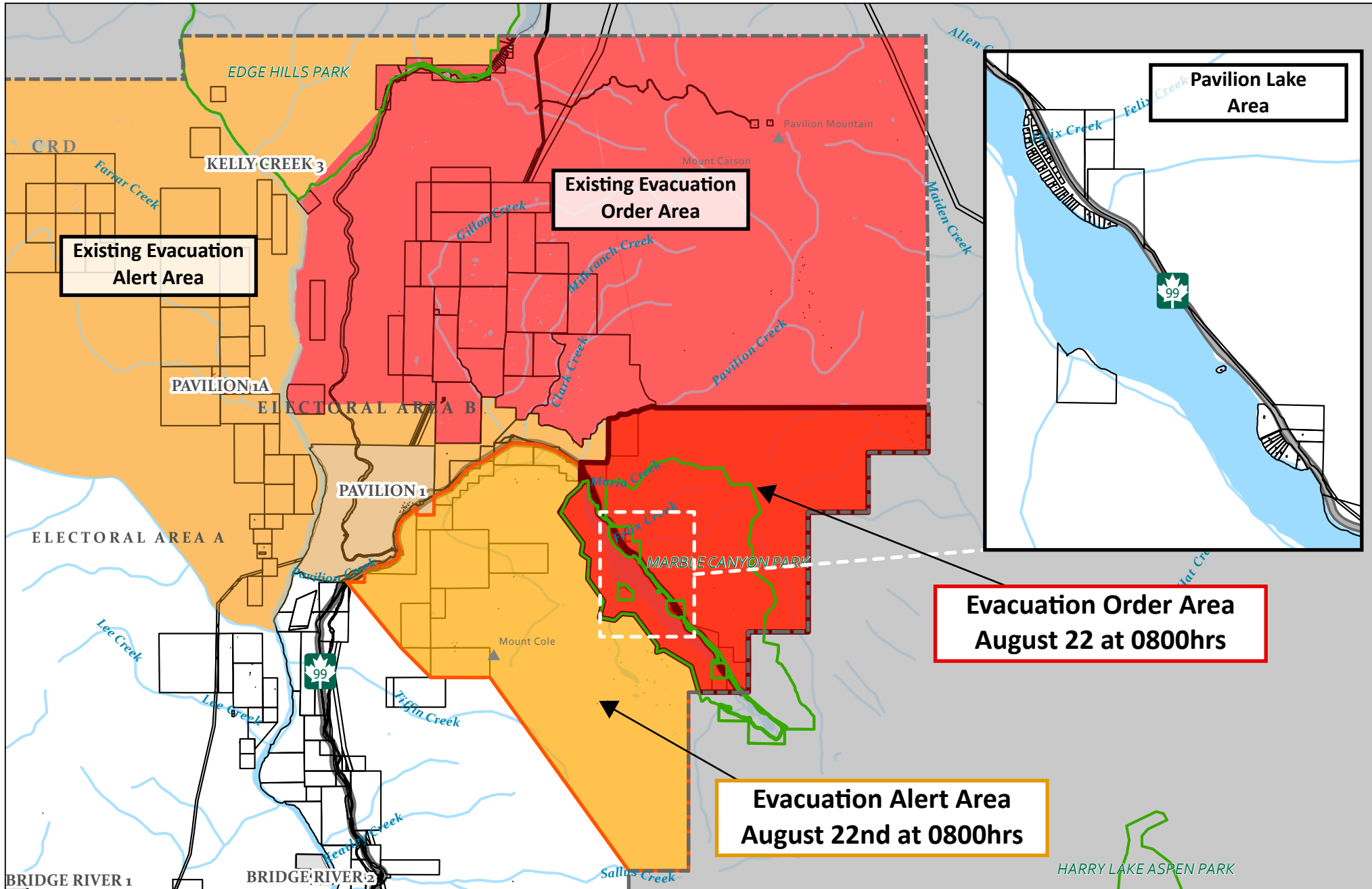
