

**EVACUATION ORDER – SLRD ELECTORAL AREA B
RILEY CREEK WILDFIRE K70659**

July 31, 2026, at 19:00 hrs

Pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, an EVACUATION ORDER has been issued by the Squamish-Lillooet Regional District due to immediate danger to public safety caused by the Riley Creek Wildfire in the Texas Creek area effective July 31, 2026 at 1900 hrs. Members of the Royal Canadian Mounted Police and other applicable agencies will be expediting this action.

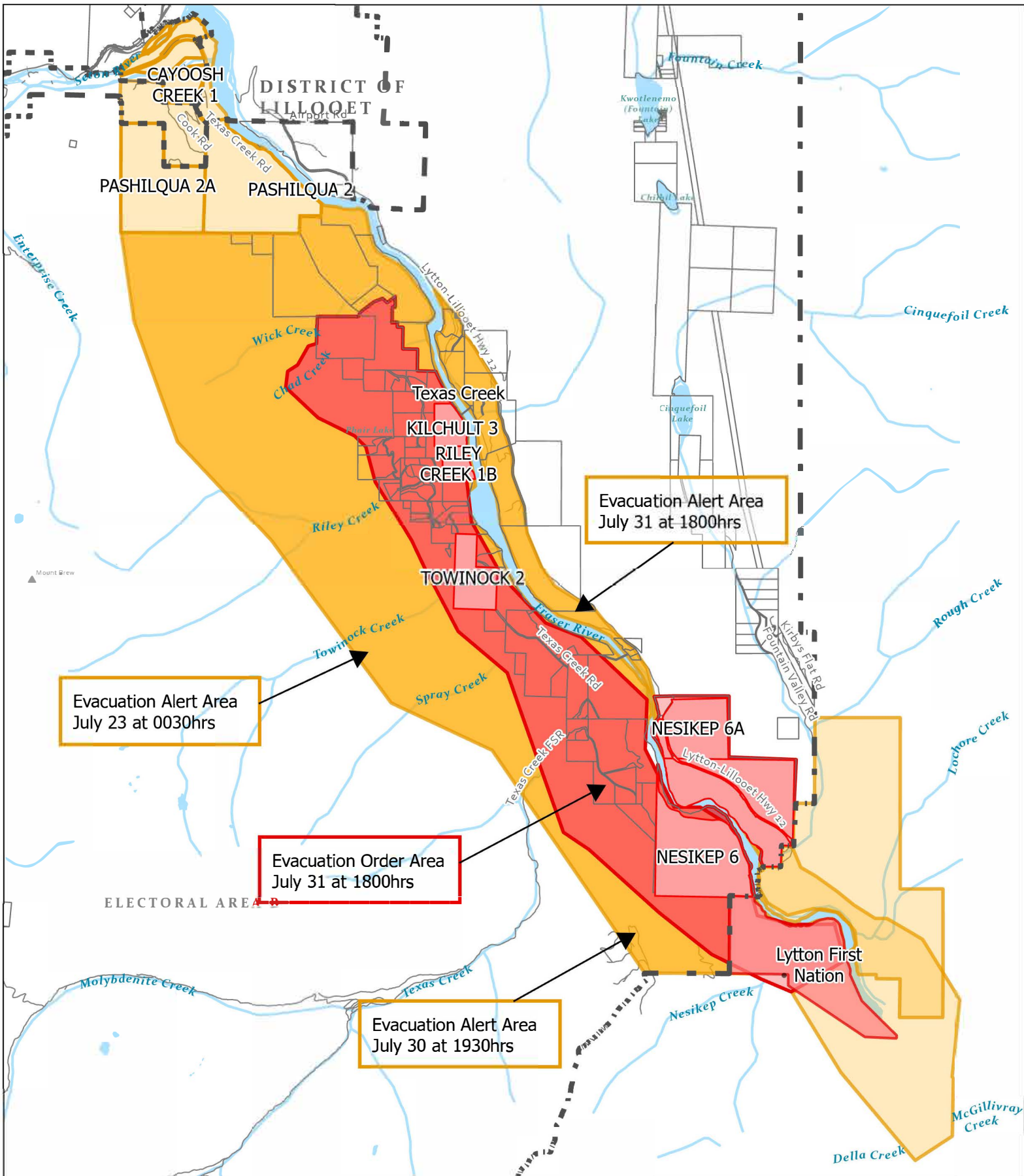
