Qualifications for Office

A person is qualified to be nominated, elected, and to hold office as a trustee if, at the relevant time, they meet all of the following requirements:

- Must be at least 18 years of age as of October 17, 2026;
- Must be a Canadian citizen;
- Must have been a resident of British Columbia for at least six (6) months immediately prior to the date nomination papers are filed;
- Must not be disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or from being nominated for, being elected to, or holding the office, or be otherwise disqualified by law.

Campaign Period Expense Limits

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general school elections, the expense limit for candidates during the campaign period in Trustee Electoral Area 4 and Trustee Electoral Area 5 is \$6,161.89.

Third Party Advertising Limits

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general school elections, the third party directed advertising expense limit of \$924.28 applies to Trustee Electoral Area 4 and Trustee Electoral Area 5. The third party cumulative advertising expense limit is \$184,856.70 and applies to directed and issue advertising in all election areas. The total value of all advertising sponsored cannot exceed this limit.
