Date: August 12, 2026

WHEREAS a state of local emergency was declared on 07/31/2026 in relation to the wildfire risk in the area of Electoral Area B of the Squamish-Lillooet Regional District (SLRD);

AND WHEREAS life and property remain at risk due to continued wildfire risk in Electoral Area B, SLRD;

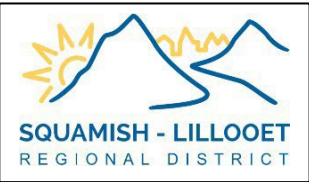

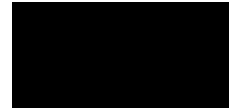

AND WHEREAS the following consultation was done under section 120(3) in relation to the exercise of the powers under section 107:

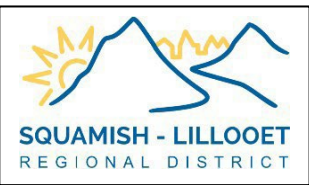
