

EVACUATION ORDER - SLRD ELECTORAL AREA C TWIN TWO CREEK WILDFIRE V30941

UPDATED: July 30, 2026, at 1630hrs

Pursuant to Section 95 (1) of the BC Emergency and Disaster Management Act, an EVACUATION ORDER issued by the Squamish-Lillooet Regional District due to immediate danger to public safety caused by the Twin Two Creek Wildfire has been EXPANDED to include additional properties north of the existing evacuation order. Members of the Royal Canadian Mounted Police and other applicable agencies will be expediting this action.

The EVACUATION ORDER issued on July 23, 2026, for properties in the Twin Two Creek area remains in effect. Adjacent properties that were previously on Evacuation Alert are now on EVACUATION ORDER effective July 30, 2026.

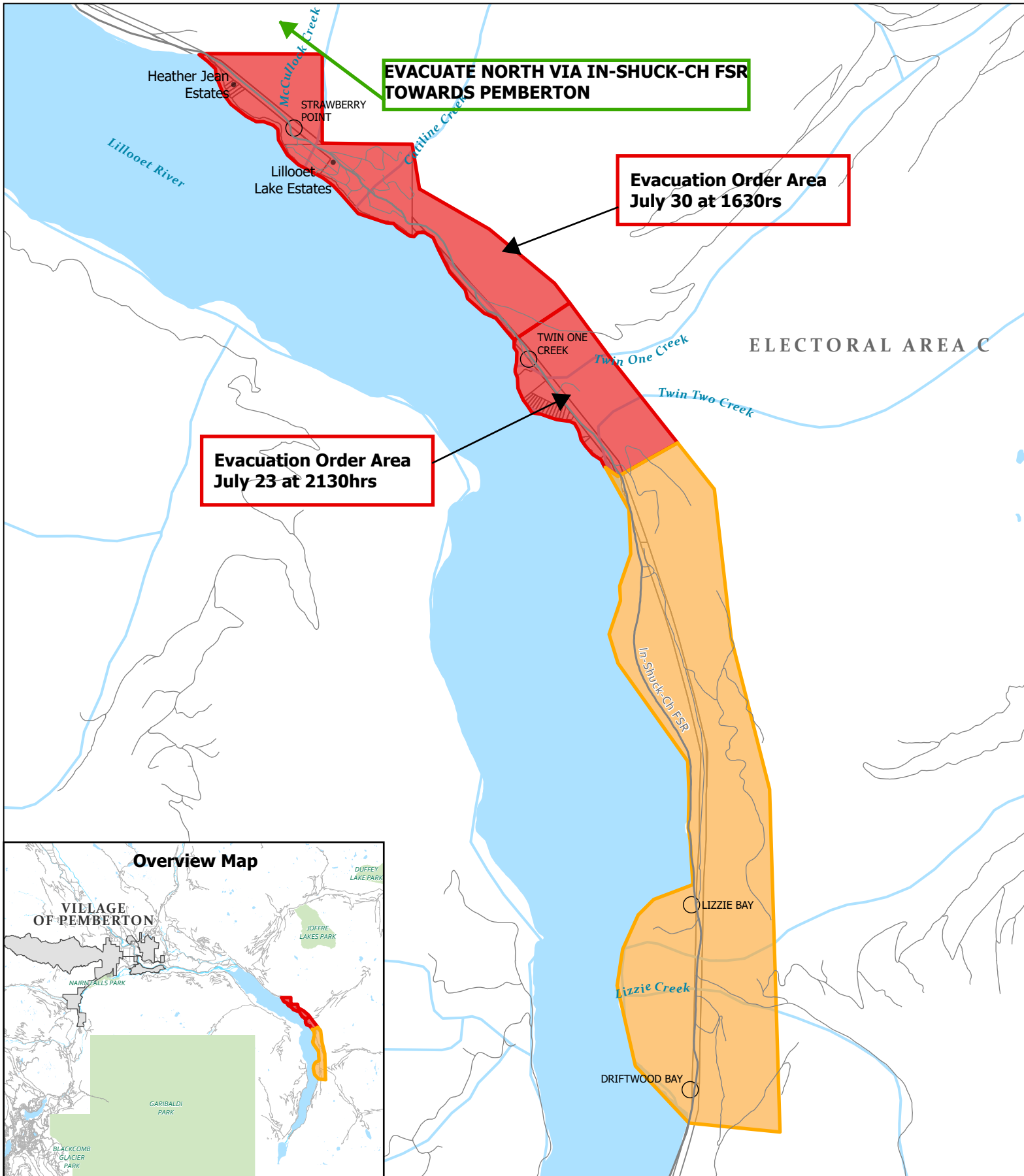
