QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day (October 20, 2018);
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified under the *School Act* or any other enactment from being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2018 general local elections, the expense limit for candidates in School District No. 48 (Sea to Sky)'s Trustee Electoral Areas C and D during the campaign period is \$5,000.

THIRD PARTY ADVERTISING LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2018 general local elections, the third party advertising limit is \$750.
