INSTRUCTIONS FOR REQUESTING A MAIL BALLOT**


1. The period that you may submit a request for a mail ballot package starts on August 5, 2022 and ends on October 13, 2022 at 4:30 p.m. **However, if you wish to vote by mail, it is recommended that you submit your request as early as possible during this period.**
2. If you have submitted a request prior to September 22, 2022, your application is complete and you qualify to vote, the earliest date by which a Mail Ballot Package is expected to be made available to you (for pick-up or by mail) is September 26, 2022.
3. The Chief Election Officer will continue to accept requests for mail ballots after September 22, 2022 up until October 13, 2022 at 4:30 p.m. - however, the likelihood that you will have sufficient time to return your Mail Ballot Package by the deadline decreases exponentially as general voting day approaches. *Please submit your request as early as possible.*

5. I request that I receive a ballot to vote by mail, under the provisions of section 110 of the *Local Government Act*, in the election on October 15, 2022.

6. I am requesting a mail ballot for Trustee Electoral Area 4 (SLRD Electoral Area C).

[Note: To register as a non-resident property elector for Trustee Electoral Area 4, a person must not be a Resident Elector of Trustee Electoral Area 4 or any other trustee electoral area of the Sea to Sky School District AND a person can only register as a Non-Resident Property Elector in relation to one parcel of land in the Sea to Sky School District. As a result, a person can register as an elector in only one trustee electoral area in the Sea to Sky School District. Please refer to the Mail Ballot Information Sheet for examples.

- ✓ 18 years of age or older on general election day (October 15, 2022); and
- ✓ a Canadian citizen; and
- ✓ a resident of BC for at least six months immediately before the day of voter registration; and
- ✓ not disqualified by law from voting in an election or otherwise disqualified by law.

a resident of Trustee Electoral Area 4 (SLRD Electoral Area C).
