

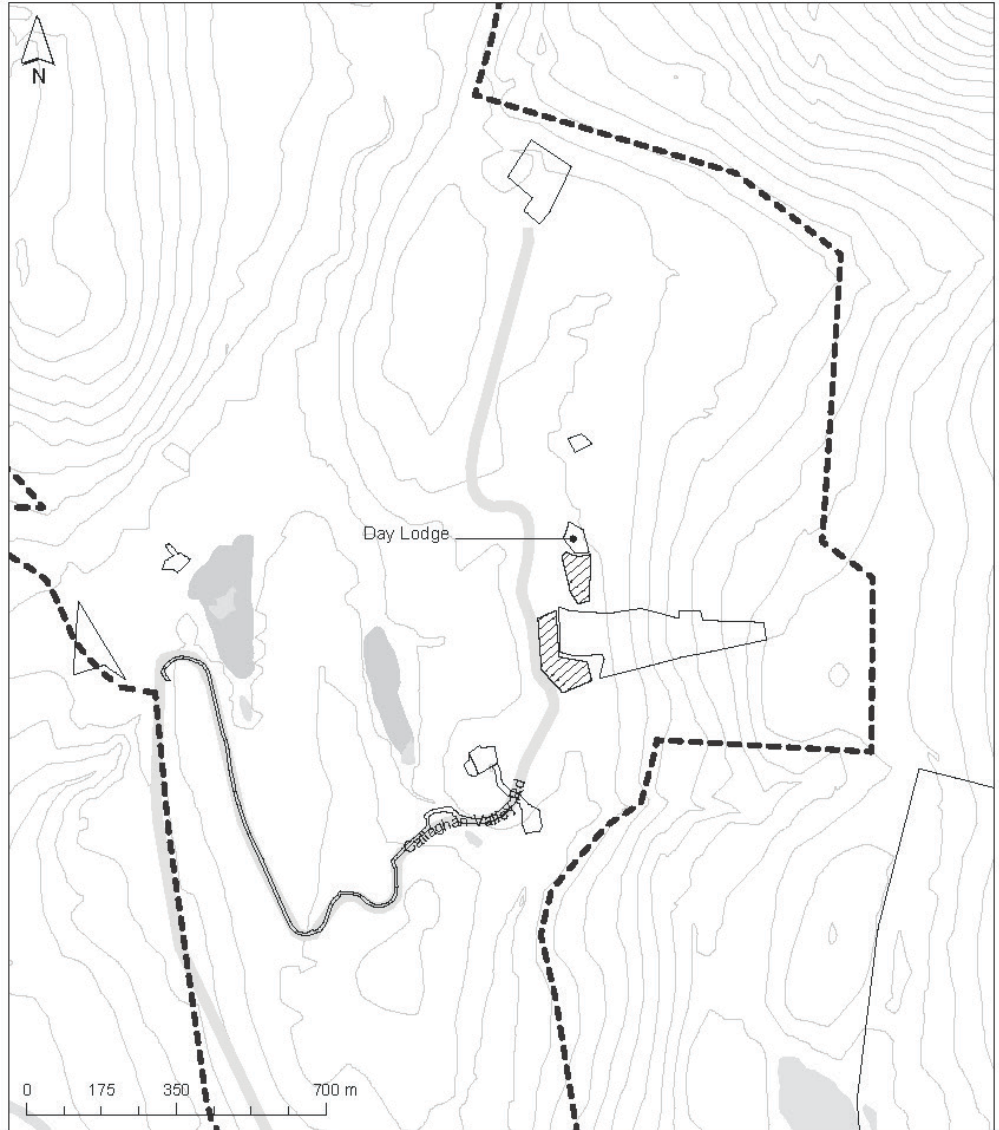
**SQUAMISH-LILLOOET REGIONAL DISTRICT
ELECTORAL AREA D ZONING BYLAW NO. 1350-2016
AMENDMENT BYLAW NO. 1673-2020**

A bylaw of the Squamish-Lillooet Regional District to amend
Squamish-Lillooet Regional District Electoral Area D Zoning Bylaw No. 1350-2016

WHEREAS the Board of the Squamish-Lillooet Regional District wishes to amend the Squamish-Lillooet Regional District Electoral Area D Zoning Bylaw No. 1350-2016;

NOW THEREFORE, the Regional Board of the Squamish-Lillooet Regional District, in open meeting assembled, enacts as follows:

1. This bylaw may be cited for all purposes as “Squamish-Lillooet Regional District Electoral Area D Zoning Bylaw No. 1350-2016, Amendment Bylaw No. 1673-2020”.
2. Squamish-Lillooet Regional District Electoral Area D Zoning Bylaw No. 1350-2016 is amended as follows:
 - (a) By adding the following permitted use to SECTION 11.5 – BC3 – BACKCOUNTRY COMMERCIAL 3 ZONE (Whistler Olympic Park), Section 11.5.2 (Permitted Uses):
 - *Campground*
 - (b) By adding the following provisions to SECTION 11.5 – BC3 – BACKCOUNTRY COMMERCIAL 3 ZONE (Whistler Olympic Park), Section 11.5.3 (Conditions of Use):
 - .5 Seasonal *campground use* may only operate from May 15-October 31 annually.
 - .6 No campsite may be occupied by a single camping party for a period exceeding 30 consecutive days, in accordance with Squamish-Lillooet Regional District Campground Bylaw No. 1568-2018, as amended from time to time.
 - .7 No campsite shall be located anywhere other than the locations specified on Schedule 1 below:

(c) By adding the following provisions to the table in SECTION 11.5 – BC3 – BACKCOUNTRY COMMERCIAL 3 ZONE (Whistler Olympic Park), Section 11.5.4 (Regulations):
