

**SQUAMISH LILLOOET REGIONAL DISTRICT
BYLAW NO. 1086, 2008**

A bylaw to establish the position of and appoint

Bylaw Enforcement Officers for the Regional District

The Board of the Squamish Lillooet Regional District, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited for all purposes as “Bylaw Enforcement Officer Bylaw, No. 1086, 2008”.
2. In this Bylaw
“Board” means the board of directors of the Regional District;
“Bylaw” means a bylaw of the Regional District;
“Bylaw Enforcement Officer” means a person appointed by resolution of the Board pursuant to this Bylaw;
“Regional District” means the Squamish Lillooet Regional District.
3. Words or phrases defined in the *Community Charter*, the *Local Government Act* and the *Interpretation Act*, and the regulations to those Acts, have the same meaning in this Bylaw unless otherwise defined in this Bylaw.
4. The Board of the Regional District hereby establishes the position of Bylaw Enforcement Officer.
5. The Board of the Regional District may from time to time appoint Bylaw Enforcement Officers pursuant to a resolution substantially in the form set out in Schedule “A” to this Bylaw to investigate and enforce the bylaws of the Regional District.
6. Bylaw Enforcement Officers may perform those duties and functions and have those powers, privileges and responsibilities as set out in Schedule “B” to this Bylaw.
7. Pursuant to section 269(1) of the *Community Charter*, the Board hereby delegates to Bylaw Enforcement Officers the authority to refer any disputed municipal ticket information to the Provincial Court.


8. If a court of competent jurisdiction finds any part, section or subsection of this Bylaw to be invalid or unenforceable, the impugned part, section or subsection shall be severed from the remainder of the Bylaw and the remainder of the Bylaw shall remain valid and in force.



Schedule “B”

Bylaw Enforcement Officer Duties and Powers

- Enforce regulations applicable in the Regional District subject to relevant laws, administrative directions and Board policies
- Enter, at reasonable times, on to any property to inspect and determine whether all regulations, prohibitions and requirements of the Regional District are being met
- Prosecute offences on behalf of the Regional District
- Retain and instruct legal counsel to act on behalf of the Regional District
