**Pemberton, BC** – The Squamish-Lillooet Regional District (SLRD) will host its first virtual Board Meeting, in response to the COVID-19 pandemic and the need for physical distancing to contribute to slowing transmission of the virus.

The SLRD Board Meeting will take place at 1:00 p.m. on Wednesday, April 22, 2020 and is available for viewing through livestream on the SLRD website.
